My question to the Council is: "Whereas Letcombe Regis Parish Council (LRPC) may not have the power or right, that being reserved to the Highways Authority and/or Police to close any road for any cause, I believe LRPC should seek to obtain a delegated power or right to take possession or ownership of a portable triangular roadway traffic sign with the single word 'flood' (the sign) to be displayed at the junction of Wantage Road and Challow Hill to warn motorists that the road is flooded at such time that the road becomes impassable for ordinary traffic. Further that LRPC delegates to its Responsible Officer the obligation to display the sign when a flood condition occurs and to keep that sign in place until the flood has subsided?"
